Official Plan Update

Section 26 Meeting

Official Plan Update

- A Section 26(3) Meeting is required by the Planning Act to provide members of the public an opportunity to provide comments on revisions that may be required to the Official Plan.
- The current Municipal OP was adopted in 2011 and subsequently approved by MMAH in 2013.
- The New Municipal OP will guide all land use planning and development decisions in the Municipality for the next 20 years.

Preparation of New OP

- There are several Provincial planning documents that form the basis for land use planning in Ontario.
- The Municipality of Temagami OP is required to be consistent with and have regard to:
 - The Planning Act;
 - The Provincial Policy Statement (2020); and
 - The Growth Plan for Northern Ontario (2011).

Planning & Policy Areas

- The New Municipal OP will address a variety of policy issues including:
 - Managing shoreline development
 - Settlement area development
 - Protection of Water Quality
 - Protection of Natural Environment
 - Year Round Economy
 - Growth management
 - Goals and objectives to reflect community
 - Areas of archaeological potential
 - Consultation with Temagami First Nation
 - Roads
 - Pre-consultation
 - Development on private roads or in proximity to private
 - Lake Temagami access point
 - Character on Lake Temagami
 - Home industries, home occupations, second units
 - Lake capacity
 - Wildland fire risks
 - Conversions of existing land uses
 - Land use compatibility

Planning Issues

- More employment
- Aging population
- Youth moving out
- Supports for youth
- Internet and cellular service to support work from home
- Designation of additional land to support commercial and industrial uses
- Land Claim
- Lack of population
- Climate change
- Redevelopment of shoreline residential lots
- Providing services to shoreline lots (parking, boat docking, construction staging area)

- Existing by-laws are too restrictive
