RECOMMENDATION

This memorandum is to recommend that Council consider the following motion:

BE IT RESOLVED THAT Council receive Memo 2018-M-035 regarding the Official Plan Update Process;

AND FURTHER THAT Council direct Staff to defer the issuance of a Request for Proposal for an appropriate consultant for the Official Plan update process until January.

INFORMATION

Previously, Council had issued a RFP in the hopes of engaging a consultant for the comprehensive review and update to the Official Plan. At the end of the process, the Municipality was not successful in moving this to the point of a contract.

Given the election period we are presently under, as well as the fact that establishing an RFP process at this point in the year would not result in having consultant lead public engagement during the summer period, Staff are recommending that this process be put on hold until after the election.

By issuing an RFP call in January, there should be sufficient time to engage a consultant, allow them to have a pre-consultation with the Province through the Ministry of Municipal Affairs and Housing and establish a robust schedule for public engagement during the summer of 2019.



Multi-Use Facility Project Bi-Weekly Update by Capital Projects Department

With the Multi-Use Facility Project now underway and activities ramping up, expect to see a brief update like this one every couple of weeks so that everyone is aware of how the project is going and what to expect to see happening in the weeks ahead.

Community Update



The grader gave a pass to all the roads on the island during the week of June 18th. More work is required with the grader but we are needing some rain to complete the final passes before applying the dust suppressant.

Superior Propane was on site and installed some temporary propane tanks at the contractor trailers. If you look closely at this picture, we are working on flattening out the area to the right of the excavator.


The newly flattened area will be roughly 40x40ft and this is where the tanks will be set up to ensure we have enough propane to get the camp through the winter as Superior Propane will only travel over by barge.

Temagami Electrical Services were hired to work with Hydro One to complete the electrical hook up at the contractor camp. Hydro One was in the community on Thursday June 21st, for their first inspection and the final connection of the trailers is scheduled for July 4. We are anticipating our first guests in the camp starting July 8.

TFN Communications Officer, Haley Laronde assisted us in creating a "Capital Projects Tab" on TFN's website. The tab will contain current and past notices, updates and newsletters for anyone wanting to view this information. We have also set up a tab for pictures of the project as development takes place. What's Happening at the Work Site

Despite assumptions made based on the geotechnical information, it does not appear that Quinan will be encountering any bedrock in the project location as the structural drawings identified. This is a good or bad thing,



depending on how you look at it. For the purposes of common parameters for bidding, the structural drawings noted an assumed depth of -1200mm for all bedrock locations (the gathering hall and kitchen) and include details for dowelling into rock at these locations. Considering rock would not have been consistently encountered at this elevation, a number of Unit Prices were included on the Supplementary Bid Form to address rock elevations that were either higher or lower (i.e. rock removal, rock dowels, additional masonry wall construction, etc.).

There is no bedrock present in this area so we do not need to implement any additional work associated with revised rock elevations (either

higher or lower) however we now need to introduce deeper foundations and additional foundation insulation to bear on soil as is typical of the portion of the building located north of the gathering hall. This will result in additional material and labour costs associated with excavating deeper and additional concrete block foundations and foundation insulation work. Rock dowel work as shown on the tender documents will not be required however this won't offset the other additional costs. This past week the crew concentrated on deeper excavations as this work will need to be completed before starting the formwork for the footings. I know it may be hard to visualize, I might even be making it worse by the outline as my Microsoft Paint skills are not up to par, but the outline beside you is to help visualize the outline of the new building and how it will be situated and look on the lot.



lake Temagami Access Road/Mine Landing



Quinan has appointed a logistics coordinator, he will be working at the coordinating deliveries of the barge landing and out of the staging area that Quinan has set up in the contractors side of the Mine Landing.

The staging area is set up to one side of the contractor area at the mine landing to help minimize the impact to local residents and contractors using the landing. The Tiny area circled in pink. If you look closely you can see that the staging area is roughly 40x20ft. Currently there are 2 sea cans there but the intent is to connect the containers with a roof that will provide shelter to the materials that will need to be stored there



Over the next two weeks you will continue to see aggregate trucks travelling the Access Road. There will still be deliveries of construction material, rebar, lumber, concrete. With all the sunshine we've had over the last two weeks, it hasn't allowed for the dust suppressant to be applied to the Access Road. Please allow yourselves extra travel time as these vehicles travel slowly.



Expect to see new signage at the Mine Landing. We had some initial discussions with the Municipality of Temagami in regards to putting up a sign similar to this. It's a 3x6ft sign where the intent is to display notices and regular project updates.

Miss something about capital projects or have questions about the Multi-Use Facility?

Lay abstract.

When hospital discharges are poorly planned, patients may not know how to manage their post-discharge care. They may need to visit the emergency room or be readmitted to the hospital. Hospital-to-home Transitional Care (TC) is provided by Ontario nurses to help patients and their families manage care after a hospital stay, but patients in rural areas have more emergency room visits and hospital readmissions than patients in urban areas. These trends indicate problems in TC in rural areas. Because TC was designed and evaluated with patients in urban areas, it may not meet the needs of rural patients or their families.

The overall goal of this study is to improve TC in rural areas in Ontario.

<u>This goal will be achieved by</u> inviting patients from rural areas, their families, and nurses who provide TC to them, to tell us how to revise TC to better meet their post-discharge care management needs. This will result in more relevant and feasible TC for people living in rural areas. <u>The expected impacts</u> are better prepared patients and families for managing care after hospital discharge, fewer emergency room visits and hospital readmissions, and cost savings to Ontario's healthcare system.

Dear Mayor or Council Member,

You are receiving this mailing because you have a TransCanada-operated pipeline in your area. We encourage you to spend a few moments reading the information enclosed and familiarizing yourself with the function, purpose and safety of the pipeline and how you as a public official can maintain the integrity of underground utilities. Please provide this information to your Chief Administrative Officer to share with the appropriate departments.

Preventing Pipeline Damage. There are three steps government entities can take to help in the prevention of damage to underground utilities, including natural gas or oil pipelines:

- 1. Avoid building structures on pipeline rights-of-way. TransCanada and other pipeline operators need access to their rights-of-way for maintenance and emergency response.
- 2. Require all employees and contractors to request a locate by contacting their local One-Call Centre either by phone or online at www.clickbeforeyoudig.com before excavating.
- Always report damage of a utility to the local One-Call Centre and the utility operator. Unreported and even minor damage has the potential to cause long-term damage to pipelines.

Emergency Preparedness and Response. Although pipeline leaks and ruptures are rare, it is important that you know how to respond in the event of an incident. Make sure you have a coordinated plan with pipeline operators, local emergency management officials and HAZMAT.

Land Use and Urban Development. It is important to consider the location of pipelines and other underground utilities for land development and urban planning in your community. Look for pipeline marker signs which indicate a pipeline is in the area and always contact the One-Call Centre before any excavation.

Responding to Public Inquiries. Our effectiveness studies have shown that the public relies on local government for safety information. Constituents in your jurisdiction may contact you with questions about underground utilities (where they are, who operates them, etc.). It is important to remind the public to always contact the local One-Call Centre before beginning any excavation deeper than 30cm. For questions about TransCanada's pipelines in particular, please direct them to our website at www.transcanada.com or provide our contact information (listed below).



Pipelines

Pipelines are the safest and most efficient method to transport energy to market. Our pipelines are built using industry best practices, which include using the highest quality materials during the construction and implementing routine quality inspections and monitoring the pipeline 24 hours per day from TransCanada's Operations Control Centre.

Meter Stations

Meter stations are facilities necessary within a pipeline system that measure the volume of natural gas transported by a pipeline. Natural gas is measured at all locations where it either enters the pipeline (receipt station) or leaves the pipeline (sales station).

Compressor Stations

As natural gas flows along a pipeline, it slows due to friction between it and the pipeline. This results in a loss of pressure along the pipeline. In order to make the gas flow continuously at the desired flow rate, it is re-pressurized at suitable locations along the pipeline. This is done by mechanically compressing the gas at sites connected to the pipeline known as compressor stations. The location and quantity of compressor stations required in a pipeline system is dependent on a number of factors, including the operating pressure of the pipeline, the diameter of the pipe used, elevation changes along the pipeline route and the desired volume of gas to be delivered.

Maintaining Pipeline Safety

- TransCanada conducts a rigorous pipeline maintenance program to ensure the integrity and safety of our systems. This includes but is not limited to ground surveys, cathodic protection, hydrostatic testing, investigative digs, patrols and in-line inspections.
- TransCanada meets or exceeds all applicable federal and provincial safety standards.
- The pipeline facilities are constantly monitored to ensure safety and integrity of the
- TransCanada patrols pipeline rights-of-way to identify any unsafe or unauthorized activity within the rights-of-way which could damage the pipeline.

Pipeline Location

- Most pipelines are buried underground in an area of cleared land often referred to as the "right-of-way". Markers are used to indicate the approximate location of the pipeline, as well as important information such as the pipeline operator, the product shipped in the pipeline, and emergency contact information.
- Only a TransCanada representative can determine the location and depth of the pipeline. Pipelines may not follow a straight course between marker signs, so please ensure you request a locate prior to excavating.
- If you observe any unusual or suspicious activities near a pipeline, please immediately
 - report the issue to law enforcement or the pipeline company.

Approvals for Working around TransCanada's Facilities

To ensure our pipelines and facilities operate safely, written consent from TransCanada must be obtained in Canada before any of the following:

- Constructing or installing a facility across, on, along or under a TransCanada pipeline
- Conducting ground disturbance (excavation or digging) on or within the prescribed area (30 metres or 100 feet from the centreline of the pipeline).
- Driving a vehicle, mobile equipment or machinery across a TransCanada pipeline right-of-way outside the travelled portion of a highway or public road.
- Using any explosives within 300 metres or 1,000 feet of TransCanada's pipeline
- Use of the prescribed area for storage purposes.

Steps Before Starting Work:

- Make a locate request either online (www.clickbeforeyoudig.com), via mobile apps (Alberta, Saskatchewan and Quebec) or via phone (see the back of this booklet). The One-Call Centre will notify owners of buried utilities in your area, who will send representatives to mark these facilities with flags, paint or other marks, helping you avoid damaging them.
- Apply for written consent using TransCanada's new online application form (writtenconsent.transcanada.com or call 1.877.872.5177). Often written consent for minor activities can be obtained directly from a regional TransCanada representative through a locate request.



What is the prescribed area?

The prescribed area extends 30 metres on either side of the pipeline centreline. Excavation or ground disturbance within this zone requires written consent except for certain types of agricultural activities. See the "Agriculture Safety" section below, or contact TransCanada for more information on permissable agriculture activities. The existence of the prescribed area does not necessarily mean development of the land cannot occur within the prescribed area, so contact TransCanada early to discuss your plans.



Agriculture Safety

TransCanada wants to ensure the safety of anyone living or working near our facilities, and that includes Canada's active farming community.

Normal farming practices can be completed without notice to TransCanada or contacting the One-Call Centre, but ground disturbance and some other activities can pose a risk to underground utilities and may require written consent.

Excavate carefully

Hand dig to determine exact locations of pipelines. A TransCanada representative must be present. All digging must take place during the time allotted by the TransCanada representative.

Pipeline Incidents


A pipeline incident could involve an uncontrolled or unplanned release of natural gas from the pipeline system. TransCanada's state-of-the-art leak detection systems, elevated safety features and specially trained staff ensure that leaks are quickly identified and addressed.

In the unlikely event an incident should occur, TransCanada will immediately investigate and respond by shutting down the pipeline (if necessary) and dispatching emergency personnel to the location of the incident. Valves spaced at intervals along all TransCanada pipelines will be shut off allowing the natural gas to be quickly and effectively isolated.

Trained crews dispatched to the site will work to further isolate the area and coordinate a response with local emergency services.

TransCanada will not restart the pipeline until the issue has been addressed and it is safe to do so.

TransCanada's policies and practices for emergency response planning go above and beyond the standard regulatory requirements for emergency response.

Pipeline Markers

- Pipeline marker signs contain important information, including the owner of the pipeline, the product shipped in the pipeline and emergency contact numbers.
- TransCanada uses a variety of markers and signs along rights-of-way to alert people to the general location of its pipelines. Markers are typically placed where the pipeline intersects roads, railroads, rivers, fence lines and in heavily congested areas.
- BE AWARE: Pipeline markers will not designate the exact location, depth or number of pipelines in the area. Contact your local One-Call Centre and TransCanada and other utility companies will send a representative to the proposed excavation site to mark buried utilities at no cost to you.
- It is against the law to willfully and knowingly deface, damage, remove or destroy any pipeline sign. If these signs are missing, damaged or otherwise unreadable, please contact TransCanada to replace them.



Safety in the Community

Safety is a core value at TransCanada. We make safety – for ourselves, each other, our contractors and for members of our communities – an integral part of the way we work. TransCanada's operations extend across North America with established offices in key communities. Each region is fully staffed with qualified employees trained in pipeline safety and emergency response to ensure the safe and efficient operation of the facilities in the area.

We view the communities in which we operate as emergency response partners. We work collaboratively with these stakeholders on a continuous basis, inviting them to participate in exercises and training.

We work with emergency response officials to ensure everyone is familiar with local operations and is ready to respond in the event of an incident.

What to do if you strike a pipeline

A "strike" is any unauthorized contact with a pipeline and can include mechanical equipment like a backhoe or hand tools, such as a shovel. Whether or not the pipe appears to be damaged, if you strike a pipeline, it is important that you follow these steps:

- I. Stop all excavation and construction. Shut off all machinery and move away from the area on foot warn others to do the same.
- 2. Do not attempt to repair the pipe or operate any valves.
- **3.** Call **'911**' as soon as you are in a safe location. Describe the situation and inform the operator of any injuries, leaking product or fire.
- 4. Call TransCanada's emergency number at **1.888.982.7222** and explain the incident. This number is available on all pipeline marker signs.
- 5. Do not continue your project until authorized by a TransCanada representative.

The safety of the surrounding population dramatically decreases when a pipeline is damaged. Contact TransCanada as soon as possible so we can make any necessary repairs.

Being a Partner in Pipeline Safety

Although a pipeline leak is rare, it is important to know how to recognize the signs. Use your senses of smelling, seeing and hearing to detect a potential pipeline leak.

What you may smell

 Transmission lines that transport natural gas across Canada are rarely odourized, but may have a slight hydrocarbon smell. Distribution lines that transport natural gas to homes and businesses are odourized and could smell "skunk-like" or similar to rotten eggs.

What you may see

- Dead or dying vegetation on or near a pipeline in a normally green area
- Water bubbling or blowing into the air at a pond, creek or river
- Dirt being blown or appearing thrown into the air
- An accumulation of ice or frost over the pipeline (in the summer)

What you may hear

• A hissing, roaring or bubbling sound

If You Suspect a Leak


If you witness any of the typical signs listed, or any other unusual sights, sounds or smells near a pipeline location, it is important that you follow these steps:

- **1. Leave** the area immediately on foot do not use motor vehicles or any equipment that could be a potential ignition source.
- 2. Move to a safe location, call '911'.
- **3. Call** TransCanada's emergency number: **1.888.982.7222**. This number can be found on all pipeline marker signs.
- 4. Warn others to stay away.



AND WHEREAS the Municipal Act defines "general local municipality levy" as the amount the local municipality decided to raise in its budget for the year under section 290 on all rateable property in the local municipality;

AND WHEREAS the Council of the Corporation of the Municipality of Temagami has, passed By-law 18-1407 to adopt the estimates of the Municipality the sums to be raised for the year in accordance with Section 290 of the Act;

AND WHEREAS the money estimated by said by-law to be levied by taxation for general municipal purpose and Payments in Lieu of taxes is \$3,790,586

AND WHEREAS it is necessary for the Council of the Municipality of Temagami pursuant to the *Municipal Act* to levy on the whole rateable property according to the last revised assessment roll for the Corporation of the Municipality of Temagami the estimates of all sums required for the purposes of the Corporation;

AND WHEREAS the "Commercial Assessment", "Industrial Assessment" and "Pipeline Assessment" and the applicable subclasses pursuant to Section 7 of the *Assessment Act* have been determined on the basis of the aforementioned property assessment rolls;

AND WHEREAS those tax rates on the aforementioned "Commercial Assessment", "Industrial Assessment" and "Pipeline Assessment" and the applicable subclasses have been calculated pursuant to the provisions of the *Municipal Act* R.S.O. 2001, c 25, as amended, and the provisions of the *Education Act* in the manner set out herein;

AND WHEREAS the assessment for the Municipality of Temagami, in accordance with the previous year end Assessment Roll, for general municipal purposes is as follows:

Every owner of land shall be taxed accordingly to the tax rates in this by-law and such tax shall become due and payable in 2 instalments as follows: 50 percent of the final levy shall become due and payable on the date stipulated on the final tax billing notice, which shall be at least 21 days following the date of mailing of the tax bills; the second due date shall be stipulated on the final tax billing notice; and
- 4. Notwithstanding item 3 above, the Treasurer of the Corporation of the Municipality of Temagami is hereby authorized to accept payments based on monthly payment plans; and
- **5.** Amounts required to be levied and collected by this By-law shall be reduced by the amounts levied and collected by the Interim tax levy as authorized by By-law No. 18-1383 of the Corporation of the Municipality of Temagami; and
- 6. The Treasurer of the Corporation of the Municipality of Temagami shall mail or cause to be mailed to the address of the residence or place of business of each property or person, a notice specifying the amount of taxes payable by such persons pursuant to the provisions of this by-law, and
- 7. The taxes payable pursuant to this by-law shall be paid into the office of the Treasurer for the Corporation of the Municipality of Temagami on or before the respective dates herein before set forth; and
- 8. The Treasurer is hereby authorized to accept part payment from time to time, on account, of any taxes which have become due pursuant to this by-law.
- 9. In default of payment of the full amount of any taxes by the respective due dates, a percentage charge, of 1¼ % of the amount of taxes due and unpaid, may be imposed as a penalty for the non-payment of taxes on the first day of default. In addition, interest charges in the amount of 1¼ % per month, or 15% per annum, shall be levied on unpaid taxes in the manner established by section 345 of the *Municipal Act*; and

- 10. If any section or portion of this by-law is found by a Court of competent jurisdiction to be invalid, it is the intent of Council for the Corporation of the Municipality of Temagami that all remaining sections and portions of this by-law continue in force and effect; and







Multi-Use Facility Project Bi-Weekly Update by Capital Projects Department

With the Multi-Use Facility Project now underway and activities ramping up, expect to see a brief update like this one every couple of weeks so that everyone is aware of how the project is going and what to expect to see happening in the weeks ahead.

Community Update



The grader gave a pass to all the roads on the island during the week of June 18th. More work is required with the grader but we are needing some rain to complete the final passes before applying the dust suppressant.

Superior Propane was on site and installed some temporary propane tanks at the contractor trailers. If you look closely at this picture, we are working on flattening out the area to the right of the excavator.


The newly flattened area will be roughly 40x40ft and this is where the tanks will be set up to ensure we have enough propane to get the camp through the winter as Superior Propane will only travel over by barge.

Temagami Electrical Services were hired to work with Hydro One to complete the electrical hook up at the contractor camp. Hydro One was in the community on Thursday June 21st, for their first inspection and the final connection of the trailers is scheduled for July 4. We are anticipating our first guests in the camp starting July 8.

TFN Communications Officer, Haley Laronde assisted us in creating a "Capital Projects Tab" on TFN's website. The tab will contain current and past notices, updates and newsletters for anyone wanting to view this information. We have also set up a tab for pictures of the project as development takes place. Check it out at https://www.temagamifirstnation.ca/capital-projects

What's Happening at the Work Site

Despite assumptions made based on the geotechnical information, it does not appear that Quinan will be encountering any bedrock in the project location as the structural drawings identified. This is a good or bad thing,



depending on how you look at it. For the purposes of common parameters for bidding, the structural drawings noted an assumed depth of -1200mm for all bedrock locations (the gathering hall and kitchen) and include details for dowelling into rock at these locations. Considering rock would not have been consistently encountered at this elevation, a number of Unit Prices were included on the Supplementary Bid Form to address rock elevations that were either higher or lower (i.e. rock removal, rock dowels, additional masonry wall construction, etc.).

There is no bedrock present in this area so we do not need to implement any additional work associated with revised rock elevations (either

higher or lower) however we now need to introduce deeper foundations and additional foundation insulation to bear on soil as is typical of the portion of the building located north of the gathering hall. This will result in additional material and labour costs associated with excavating deeper and additional concrete block foundations and foundation insulation work. Rock dowel work as shown on the tender documents will not be required however this won't offset the other additional costs. This past week the crew concentrated on deeper excavations as this work will need to be completed before starting the formwork for the footings. I know it may be hard to visualize, I might even be making it worse by the outline as my Microsoft Paint skills are not up to par, but the outline beside you is to help visualize the outline of the new building and how it will be situated and look on the lot.



lake Temagami Access Road/Mine Landing



Quinan has appointed a logistics coordinator, he will be working at the coordinating deliveries of the barge landing and out of the staging area that Quinan has set up in the contractors side of the Mine Landing.

The staging area is set up to one side of the contractor area at the mine landing to help minimize the impact to local residents and contractors using the landing. The Tiny area circled in pink. If you look closely you can see that the staging area is roughly 40x20ft. Currently there are 2 sea cans there but the intent is to connect the containers with a roof that will provide shelter to the materials that will need to be stored there



Over the next two weeks you will continue to see aggregate trucks travelling the Access Road. There will still be deliveries of construction material, rebar, lumber, concrete. With all the sunshine we've had over the last two weeks, it hasn't allowed for the dust suppressant to be applied to the Access Road. Please allow yourselves extra travel time as these vehicles travel slowly.



Expect to see new signage at the Mine Landing. We had some initial discussions with the Municipality of Temagami in regards to putting up a sign similar to this. It's a 3x6ft sign where the intent is to display notices and regular project updates.

Lay abstract.

When hospital discharges are poorly planned, patients may not know how to manage their post-discharge care. They may need to visit the emergency room or be readmitted to the hospital. Hospital-to-home Transitional Care (TC) is provided by Ontario nurses to help patients and their families manage care after a hospital stay, but patients in rural areas have more emergency room visits and hospital readmissions than patients in urban areas. These trends indicate problems in TC in rural areas. Because TC was designed and evaluated with patients in urban areas, it may not meet the needs of rural patients or their families.

The overall goal of this study is to improve TC in rural areas in Ontario.

<u>This goal will be achieved by</u> inviting patients from rural areas, their families, and nurses who provide TC to them, to tell us how to revise TC to better meet their post-discharge care management needs. 





Dear Mayor or Council Member,

You are receiving this mailing because you have a TransCanada-operated pipeline in your area. We encourage you to spend a few moments reading the information enclosed and familiarizing yourself with the function, purpose and safety of the pipeline and how you as a public official can maintain the integrity of underground utilities. Please provide this information to your Chief Administrative Officer to share with the appropriate departments.

Preventing Pipeline Damage. There are three steps government entities can take to help in the prevention of damage to underground utilities, including natural gas or oil pipelines:

- 1. Avoid building structures on pipeline rights-of-way. TransCanada and other pipeline operators need access to their rights-of-way for maintenance and emergency response.
- 2. Require all employees and contractors to request a locate by contacting their local One-Call Centre either by phone or online at www.clickbeforeyoudig.com before excavating.
- Always report damage of a utility to the local One-Call Centre and the utility operator. Unreported and even minor damage has the potential to cause long-term damage to pipelines.

Emergency Preparedness and Response. Although pipeline leaks and ruptures are rare, it is important that you know how to respond in the event of an incident. Make sure you have a coordinated plan with pipeline operators, local emergency management officials and HAZMAT.

Land Use and Urban Development. It is important to consider the location of pipelines and other underground utilities for land development and urban planning in your community. Look for pipeline marker signs which indicate a pipeline is in the area and always contact the One-Call Centre before any excavation.

Responding to Public Inquiries. Our effectiveness studies have shown that the public relies on local government for safety information. Constituents in your jurisdiction may contact you with questions about underground utilities (where they are, who operates them, etc.). It is important to remind the public to always contact the local One-Call Centre before beginning any excavation deeper than 30cm. For questions about TransCanada's pipelines in particular, please direct them to our website at www.transcanada.com or provide our contact information (listed below).



Our Natural Gas Facilities

TransCanada owns and operates pipeline and other associated natural gas facilities including meter stations and compressor stations.

Pipelines

Pipelines are the safest and most efficient method to transport energy to market. Our pipelines are built using industry best practices, which include using the highest quality materials during the construction and implementing routine quality inspections and monitoring the pipeline 24 hours per day from TransCanada's Operations Control Centre.

Meter Stations

Meter stations are facilities necessary within a pipeline system that measure the volume of natural gas transported by a pipeline. Natural gas is measured at all locations where it either enters the pipeline (receipt station) or leaves the pipeline (sales station).

Compressor Stations

As natural gas flows along a pipeline, it slows due to friction between it and the pipeline. This results in a loss of pressure along the pipeline. In order to make the gas flow continuously at the desired flow rate, it is re-pressurized at suitable locations along the pipeline. This is done by mechanically compressing the gas at sites connected to the pipeline known as compressor stations. The location and quantity of compressor stations required in a pipeline system is dependent on a number of factors, including the operating pressure of the pipeline, the diameter of the pipe used, elevation changes along the pipeline route and the desired volume of gas to be delivered.

Maintaining Pipeline Safety

- TransCanada conducts a rigorous pipeline maintenance program to ensure the integrity and safety of our systems. This includes but is not limited to ground surveys, cathodic protection, hydrostatic testing, investigative digs, patrols and in-line inspections.
- TransCanada meets or exceeds all applicable federal and provincial safety standards.
- The pipeline facilities are constantly monitored to ensure safety and integrity of the
- TransCanada patrols pipeline rights-of-way to identify any unsafe or unauthorized activity within the rights-of-way which could damage the pipeline.

Pipeline Location

- Most pipelines are buried underground in an area of cleared land often referred to as the "right-of-way". Markers are used to indicate the approximate location of the pipeline, as well as important information such as the pipeline operator, the product shipped in the pipeline, and emergency contact information.
- Only a TransCanada representative can determine the location and depth of the pipeline. Pipelines may not follow a straight course between marker signs, so please ensure you request a locate prior to excavating.
- If you observe any unusual or suspicious activities near a pipeline, please immediately
 - report the issue to law enforcement or the pipeline company.

Approvals for Working around TransCanada's Facilities

To ensure our pipelines and facilities operate safely, written consent from TransCanada must be obtained in Canada before any of the following:

- Constructing or installing a facility across, on, along or under a TransCanada pipeline
- Conducting ground disturbance (excavation or digging) on or within the prescribed area (30 metres or 100 feet from the centreline of the pipeline).
- Driving a vehicle, mobile equipment or machinery across a TransCanada pipeline right-of-way outside the travelled portion of a highway or public road.
- Using any explosives within 300 metres or 1,000 feet of TransCanada's pipeline
- Use of the prescribed area for storage purposes.

Steps Before Starting Work:

in Canada*.

- Make a locate request either online (www.clickbeforeyoudig.com), via mobile apps (Alberta, Saskatchewan and Quebec) or via phone (see the back of this booklet). The One-Call Centre will notify owners of buried utilities in your area, who will send representatives to mark these facilities with flags, paint or other marks, helping you avoid damaging them.
- Apply for written consent using TransCanada's new online application form (writtenconsent.transcanada.com or call 1.877.872.5177). Often written consent for minor activities can be obtained directly from a regional TransCanada representative through a locate request.



What is the prescribed area?

The prescribed area extends 30 metres on either side of the pipeline centreline. Excavation or ground disturbance within this zone requires written consent except for certain types of agricultural activities. See the "Agriculture Safety" section below, or contact TransCanada for more information on permissable agriculture activities. The existence of the prescribed area does not necessarily mean development of the land cannot occur within the prescribed area, so contact TransCanada early to discuss your plans.



Agriculture Safety

TransCanada wants to ensure the safety of anyone living or working near our facilities, and that includes Canada's active farming community.

Normal farming practices can be completed without notice to TransCanada or contacting the One-Call Centre, but ground disturbance and some other activities can pose a risk to underground utilities and may require written consent.

The activities listed below require written consent:

- Ground leveling
- Sludge spreading
- Clearing/Brushing/ Grubbing
- Reducing or adding soil cover
- Trenching
- Earth moving
- Drainage ditch clean out

- Blasting activities Drain tile installation
 - Building construction
 - Controlled burning
 - Asphalt milling and grinding


A pipeline incident could involve an uncontrolled or unplanned release of natural gas from the pipeline system. TransCanada's state-of-the-art leak detection systems, elevated safety features and specially trained staff ensure that leaks are quickly identified and addressed.

In the unlikely event an incident should occur, TransCanada will immediately investigate and respond by shutting down the pipeline (if necessary) and dispatching emergency personnel to the location of the incident. Valves spaced at intervals along all TransCanada pipelines will be shut off allowing the natural gas to be quickly and effectively isolated.

Trained crews dispatched to the site will work to further isolate the area and coordinate a response with local emergency services.

TransCanada will not restart the pipeline until the issue has been addressed and it is safe to do so.

TransCanada's policies and practices for emergency response planning go above and beyond the standard regulatory requirements for emergency response.

Pipeline Markers

- Pipeline marker signs contain important information, including the owner of the pipeline, the product shipped in the pipeline and emergency contact numbers.
- TransCanada uses a variety of markers and signs along rights-of-way to alert people to the general location of its pipelines. Markers are typically placed where the pipeline intersects roads, railroads, rivers, fence lines and in heavily congested areas.
- BE AWARE: Pipeline markers will not designate the exact location, depth or number of pipelines in the area. Contact your local One-Call Centre and TransCanada and other utility companies will send a representative to the proposed excavation site to mark buried utilities at no cost to you.
- It is against the law to willfully and knowingly deface, damage, remove or destroy any pipeline sign. If these signs are missing, damaged or otherwise unreadable, please contact TransCanada to replace them.



Safety in the Community

Safety is a core value at TransCanada. We make safety – for ourselves, each other, our contractors and for members of our communities – an integral part of the way we work. TransCanada's operations extend across North America with established offices in key communities. Each region is fully staffed with qualified employees trained in pipeline safety and emergency response to ensure the safe and efficient operation of the facilities in the area.

We view the communities in which we operate as emergency response partners. We work collaboratively with these stakeholders on a continuous basis, inviting them to participate in exercises and training.

We work with emergency response officials to ensure everyone is familiar with local operations and is ready to respond in the event of an incident.

What to do if you strike a pipeline

A "strike" is any unauthorized contact with a pipeline and can include mechanical equipment like a backhoe or hand tools, such as a shovel. Whether or not the pipe appears to be damaged, if you strike a pipeline, it is important that you follow these steps:

- I. Stop all excavation and construction. Shut off all machinery and move away from the area on foot warn others to do the same.
- 2. Do not attempt to repair the pipe or operate any valves.
- **3.** Call **'911**' as soon as you are in a safe location. Describe the situation and inform the operator of any injuries, leaking product or fire.
- 4. Call TransCanada's emergency number at **1.888.982.7222** and explain the incident. This number is available on all pipeline marker signs.
- 5. Do not continue your project until authorized by a TransCanada representative.

The safety of the surrounding population dramatically decreases when a pipeline is damaged. Contact TransCanada as soon as possible so we can make any necessary repairs.

Being a Partner in Pipeline Safety

Although a pipeline leak is rare, it is important to know how to recognize the signs. Use your senses of smelling, seeing and hearing to detect a potential pipeline leak.

What you may smell

 Transmission lines that transport natural gas across Canada are rarely odourized, but may have a slight hydrocarbon smell. Distribution lines that transport natural gas to homes and businesses are odourized and could smell "skunk-like" or similar to rotten eggs.

What you may see

- Dead or dying vegetation on or near a pipeline in a normally green area
- Water bubbling or blowing into the air at a pond, creek or river
- Dirt being blown or appearing thrown into the air
- An accumulation of ice or frost over the pipeline (in the summer)

What you may hear

• A hissing, roaring or bubbling sound

If You Suspect a Leak


If you witness any of the typical signs listed, or any other unusual sights, sounds or smells near a pipeline location, it is important that you follow these steps:

- **1. Leave** the area immediately on foot do not use motor vehicles or any equipment that could be a potential ignition source.
- 2. Move to a safe location, call '911'.
- **3. Call** TransCanada's emergency number: **1.888.982.7222**. This number can be found on all pipeline marker signs.
- 4. Warn others to stay away.



THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

BY-LAW No. 18-1408

Being a by-law to strike rates of taxation for the Municipality of Temagami the year 2018 and to provide for the payment of taxes by instalments.

WHEREAS Section 312(2) of the Municipal Act, S.O. 2001, c25 as amended, provides that for purposes of raising the general local municipality levy, a local municipality shall, each year, pass a by-law levying a separate tax rate, as specified in the by-law, on the assessment in each property class in the local municipality rateable for local municipality purposes;

AND WHEREAS Section 342 (1) of the Municipal Act, S.O. 2001, c25 as amended, provides that a local municipality may pass by-laws providing for: (a) the payment of taxes in one amount or by instalments and the date or dates in the year for which the taxes are imposed on which the taxes or instalments are due; and (b) alternative instalments and due dates in the year for which the taxes are imposed other than those established under clause (a) to allow taxpayers to spread the payment of taxes more evenly over the year;

AND WHEREAS the Municipal Act defines "general local municipality levy" as the amount the local municipality decided to raise in its budget for the year under section 290 on all rateable property in the local municipality;

AND WHEREAS the Council of the Corporation of the Municipality of Temagami has, passed By-law 18-1407 to adopt the estimates of the Municipality the sums to be raised for the year in accordance with Section 290 of the Act;

AND WHEREAS the money estimated by said by-law to be levied by taxation for general municipal purpose and Payments in Lieu of taxes is \$3,790,586

AND WHEREAS all property assessment rolls on which the 2018 taxes are to be levied have been returned and revised pursuant to the provisions of the *Assessment Act* R.S.O. 1990 Chapter A, 31 as amended (Herein after referred to as the "*Assessment Act*") subject to appeals at present before the Assessment Review Board, the Ontario Municipal Board and the District Court;

AND WHEREAS the "Residential/Farm Assessment", "Multi-Residential Assessment", "Farmland Assessment and Managed Forests Assessment" and the applicable subclasses pursuant to Section 7 of the *Assessment Act* have been determined on the basis of the aforementioned property assessment rolls;

AND WHEREAS the tax ratios on the aforementioned property for the 2018 taxation year have been set out in By-law No. 18-1406 of the Municipality of Temagami, a copy of which is attached;
