## Good morning Sabrina

Living Temagami has 2 items that we would like included on the agenda for the next council meeting. This letter addresses the purchase and location of a Sea Container. The second email, to follow, addresses the Truth and Reconciliation event Sept 30/23 to be hosted again this year by Living Temagami.

## 1. Sea Container

Per your discussions with Dave on this matter, council did review our request to purchase a Sea Container with grant funding and place it in the location of the current shed at the Train Station.

From that council meeting, you sent the below request to ONR.

To date we are not aware that you have received a response from ONR

Dave spoke with you in August prior to the August council meeting and asked if MOT would consider that the Sea Container could be placed on MOT property at the station location. You advised, at that time, that there was a full agenda, we had missed the date to be included for August consideration by Council.

We are now asking that this item be placed on the agenda for the Sept 14/23 council meeting.

The only new information to add is that

- The same conditions apply as you outlined in your letter to ONR, except we would be making this ask of MOT rather than ONR.
- The grant funding is time sensitive and must be spent within the period of the grant which, currently ends Dec 2023
- We are within 1 month of commencing tear down of the marquee tents and going through all other equipment to address proper storage over the winter months.

Please let me know if you require additional information to support this request to Council for the Sept 14 meeting.

Hi Anne,

Thank you very much for the information you have sent over.

We currently have three community groups working out of the Temagami Train Station. The Temagami Chamber of Commerce, Temagami Community Foundation, and Living Temagami Arts and Culture.

We also have the Temagami Community Market which has been operating out of the parking lot for 14 years, which is operated by Living Temagami. As the years have progressed with the Temagami Community Market, they have been able to purchase things such as marquee tents, tables, chairs, BBQ's, sound equipment, etc. They are struggling to find a suitable location to store their equipment. Currently as you can see from the aerial photo, there is a small shed located to the North of the Station and West of the Tracks. This has been used to store their equipment for several years. The Shed is in poor condition and is becoming a safety hazard. Living Temagami has been approved for funding to purchase a 20ft Container that they would like to place in the same location as the shed. They would have local artist paint murals on the container so that it is not an eye sore, rather a focal point.

Would the ONR Permit a 20ft Container being placed in the location as shown in the Aerial Photo attached. With the understating that if at any point the ONR requested that it be moved, it would be at the container owners expense.
