Meeting Minutes:

1. Welcome (Kristin Franks)

- Kristin Franks welcomed everyone to the TEAM Highway 11 North Working Group meeting.
- Round table introductions of all team members and meeting guest attendees.

2. Action Items from Spring Meeting

3. MTO Highway Maintenance Update (Junaid Asghar)

- Junaid Asghar provided a presentation on MTO winter maintenance, including an overview of winter maintenance preparations, bare pavement standards, and specific maintenance activities in the New Liskeard and Cochrane maintenance areas.
- It was noted that the ministry's winter maintenance season is effective October 22 to April 22, with a transition period that extends one month in advance of the season and one month following the end of the season.
- An overview of the new Trans-Canada Bare Pavement Standard was provided, which requires Highways 11 and 17 to be cleared 12 hours following the end of a winter storm.
- An overview of new legislation regarding overtaking of snow plows was

provided.

4. 2+1 Model Update (Raymond Hong)

- Raymond Hong provided an update on the 2+1 Model pilot and next steps in the process.
- Aecom has been selection as the design consultant and start up meetings and progress meetings are already underway for preliminary design.
- A public information centre is planned for early 2024, and notices of study commencement have been issued. A public website will also be launched.

5. Major Capital Construction Update (Raymond Hong)

- Raymond Hong provided an update on capital construction projects and went over status of major capital projects impacting the Highway 11 north corridor.

6. Corridor Management Update (Junaid Asghar)

- Junaid Asghar provided a presentation on highway corridor management and the ministry's online Highway Corridor Management System.
- An overview of when MTO is required to be consulted on development plans was provided, as well as clarification regarding when MTO permits are required and what the limits of MTO's permit control area are.
- The ministry strongly encourages early pre-consultation for developments as this
 creates an opportunity for all parties to establish a clear understanding of the
 MTO review process specific to the planned development, as well as any
 documentation required.
- The ministry's Highway Corridor Management website can be accessed by following this link: https://www.hcms.mto.gov.on.ca/.
- To determine if subject lands fall within the ministry's permit control area, proponents can consult the link above. There, proponents can view MTO controlled areas using an interactive map to determine if permits are required from the ministry prior to beginning work. Proponents can also submit a request to initiate pre-consultation with the ministry via the link above.

7. OPP Enforcement Update (Michael Maville, Lisa Laxton)

- OPP noted that Michael Maville's role has recently changed, and that Lisa Laxton will be taking on the role of Acting Traffic Inspector with OPP for the area.
- Lisa will be included in future meetings to comment on OPP enforcement matters and considerations

8. MTO Commercial Enforcement Update (Wendy Lewis)

- Wendy Lewis provided an update on MTO commercial enforcement in the area, and noted that the data collected is showing that additional enforcement here has been successful.
- Enforcement has been pursued through a combined approach of on-road patrols and truck inspection station use.
- A focused team has been deployed in the New Liskeard and surrounding areas for approximately 9-13 weeks. In that that, the team has conducted 1096 inspections and laid 1525 charges, 370 of which were for speeding.
- Wendy Lewis also provided an overview of future enforcement and staffing plans, as well as an update on new technologies that are being used to support effective enforcement such as a mobile enforcement van.

9. Northern Ontario Transportation Planning

- Amy Leung and Bram Westfall provided a presentation on the ministry's regional transportation planning process.
- Amy Leung explained why the ministry engages in long-term transportation planning, and how this process is approached.
- Bram Westfall provided a detailed overview of the current draft plan for Northern Ontario, Connecting the North. This plan is available online at https://www.ontario.ca/page/connecting-north-draft-transportation-plan-northern-ontario.
