Bank Closing:

I have contacted the office of Larissa Hastings, Vice President Commercial Banking at Scotia Bank regarding her letter dated October 31, 2023 notifying the municipality of the Branch Closure.

I have asked her to authorize having someone speak to Council on the closing, the ramifications and whatever public notification/consultation process is in place for this type of situation.

In the process of preparing for the branch's departure, I have begun putting together packages for interested financial institutions.

I have begun this process by updating our community profiles and putting together documents we may also want to share with any potential visitor/investor to the community.

These will include Economic Overview:

General economic indicators (unemployment rate, etc.).

Infrastructure and Utilities: Details on transportation networks (roads, airports, ports, public transit).
Availability and capacity of utilities (water, electricity, gas, broadband).
Business Incentives: Information on local and provincial-level incentives for businesses.
Zoning and Land Use: Zoning regulations and land use policies.
Availability of industrial, commercial, and residential zones.
Business Support Services: Availability of business support services (incubators, accelerators, mentoring programs).
Labor Market and Education: Workforce demographics and skills.
Proximity to educational institutions and training programs.
Quality of Life: Housing options and costs.
Cultural and recreational amenities.
Healthcare facilities.
Community Engagement: Opportunities for community involvement and input.

The Temagami Region Economic Development Corporation incorporation process is nearly complete. There were many gaps and flaws in our progress to date, and I have documented the process in the form of Council resolutions and discussions at Council meetings.
