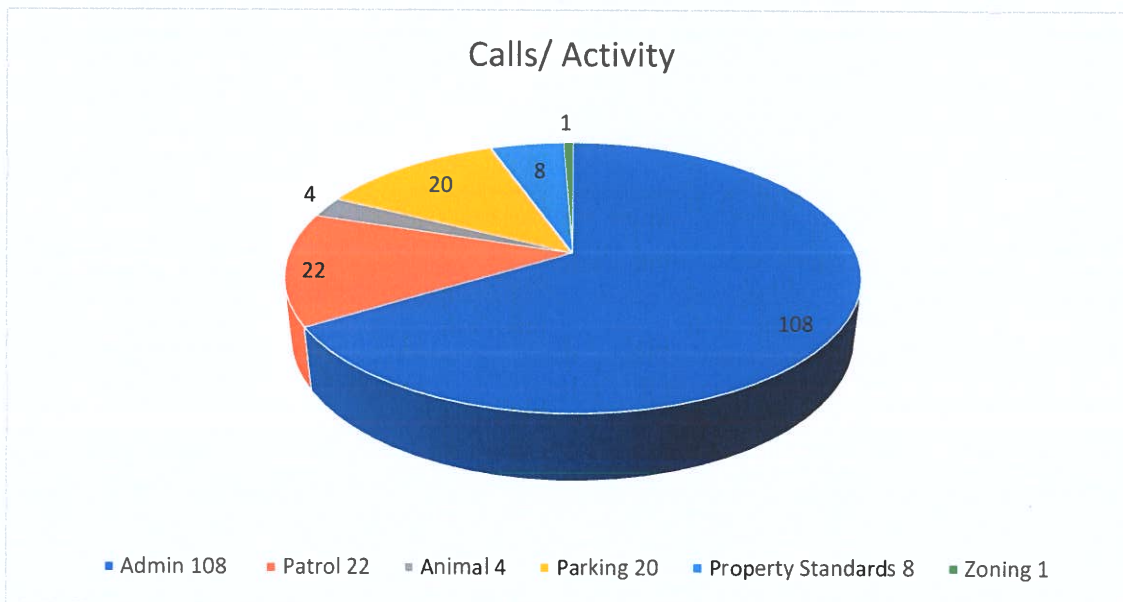
### RECOMMENDATION

**And Further That** Council does hereby acknowledge that there was overall, a total of **Thirty- Three (33)** complaints/ calls or inquiries made by the residents of Temagami during the period of **06 December 2023 to 03 January 2024**, with the majority of calls/ actions addressing **Parking and Property Standards** matters. This number does not include the anonymous complaints that have been received and / or acted upon.

### INFORMATION

This report has been generated to provide the Municipality of Temagami, Mayor and Council a detailed account of the types of calls activities and duties that I have been addressing since my **December 2023** Council Report.



**PARKING INFRACTIONS;**

Two (2) Parking Infraction Notices/ Tickets have been issued since last Council meeting. Three (3) Parking Infraction warnings were issued as part of the education and phase-in plan in Northern Temagami, in regards to parked vehicles in violation of the new No Street Parking signage.

**BY-LAW UPDATES;**

The newly proposed changes to the Firearms By-law 23-1707 had been Tabled since last Council in DEC 2023. A Public consultation event was organized and conducted on 04 JAN 2024. We are planning to have the results of the questionnaire and feed back to present to Council for the FEB 2024 regular Council Meeting.

The OPP, Cole Ritz, Ontario Federation of Anglers and Hunters, Mark Ryckman and the Delta Waterfowl Foundation, Director Brian McCrae were all invited to speak at this event.
