INFORMATION

1 Activation

March 12th @ 12:50 AM – Chimney Fire, 6131 Hwy 11 N – fire out on arrival – checked chimney pipes to confirm out – 7 firefighters and 3 vehicles responded; back in service 2:30 AM.

Training:

- 4 practices: Forest Fire Behaviour, Forcible entry, team discussion on firefighter 1 & 2 theory training delivery methodology, equipment maintenance.
- Recruit training on-going; Chris Anderson has successfully completed the recruit training curriculum; graduated to firefighter status and approved to respond to emergency activations.
- Matt Fuller & Ken Maurice completed blended NFPA 1021 Officer 1 (+80 online & classroom hrs) course & awaiting marks; Janice Bell successfully completing NFPA 1035 Fire & Life Safety Educator (on-line course), AS&E provincial exam (OFM) next step to receive certification.

Fire Prevention:

• 2 follow-up Fire Inspections, and 1 fire safety plan review outstanding.

Fire Education:

- Regular radio "fire safety" announcements on CJTT; monthly community newsletter fire safety messages; Posting Fire safety messages on Fire Department Facebook page
- Fire Safety static display at the Volunteer Firefighters Spaghetti dinner at Shiverfest

Other:

- Work continues on the Community Risk Assessment, meetings with the Marten River Fire Chief; reviewing data collection, profile tables.
- 1 Officers meeting draft annual report, firefighter training and recruit training program discussed
- Chief attended March 14th Council meeting
- Confirmed new SCBA has been received by the supplier, awaiting recalibration of supplier's porta-count respirator mask testing machine prior to scheduling training, mask fit testing and delivery.
- 2002 Rescue back in service after replacement of front stabilizer bar link assemblies and front shocks (out of service for 30 days).
- Continue to work on potential loaner/rental of water tanker for the 4-5 months when the Temagami North water tower is being replaced. We are exploring options for a fire department's soon-to-be retired tanker, as well as general inquiries looking for tankers that may be available to rent.
- Chief corrected Bell 9-1-1 database on Marten River roads inside the Municipality (9-1-1 authority)
- Chief attended trade show at Northeast Fire Education conference.
