GWP 5227-21-00**

D.M. Wills Associates Limited (Wills) has been retained by the Ministry of Transportation (MTO), to undertake a Detail Design Study and produce Contract Documents, for GWP 5227-21-00 for the Rehabilitation of Highway 11 from 0.1 km south of Lakeshore Drive northerly 0.7 km and the Rehabilitation of Wildflower Avenue from Highway 11 to Lakeshore Drive, in the Municipality of Temagami (Assignment).

As part of the Highway 11 rehabilitation work, stormwater sewer rehabilitation works will be completed, as well as an environmental assessment, natural sciences investigations, and excess soils investigations. Temporary traffic delays are anticipated on Highway 11, and a Traffic Management Plan will be developed to address potential traffic impacts as the Project progresses.

The enclosed **Key Map** illustrates the location of the Study Area.

The Process

This Project is following the approved process for a Group 'C' undertaking in accordance with the *MTO Class Environmental Assessment (EA) for Provincial Transportation Facilities (2000)*. Through this process, an Environmental Screening Document (ESD) will be prepared to document the existing conditions of the Study Area, potential impacts of the undertaking and recommendations for appropriate mitigation measures.
