- 2. **Preventative Measures:** Prioritize preventative maintenance and regular assessments to minimize long-term costs and avoid potential legal issues.
- 3. **Privacy and Compliance:** Comply with the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA) to safeguard personal data and avoid legal repercussions.

By adopting this resolution, the municipality will enhance the security and efficiency of its infrastructure and properties while addressing regulatory requirements, privacy concerns, and budget constraints.

# **INFORMATION**

Implementing CCTV systems in municipal infrastructure, including water treatment facilities, landfills, sewer systems, water systems, and municipal-owned properties where employees work and user interactions occur, aligns with the municipality's role and responsibilities to enhance security, safety, and operational efficiency. The advantages include:

#### 1. Enhanced Security

- o **Protection Against Vandalism and Theft:** CCTV serves as a deterrent against vandalism and theft, safeguarding valuable municipal assets and infrastructure.
- Monitoring Unauthorized Access: Ensures that only authorized personnel access sensitive areas, thereby upholding the municipality's responsibility to protect its facilities.
- Municipal Act, 2001: Section 8 grants municipalities the authority to enact bylaws for the protection of property, which encompasses the use of CCTV for monitoring critical infrastructure.
- o **Occupational Health and Safety Act (OHSA):** Supports the municipality's duty to provide a safe working environment by monitoring potentially hazardous areas.
