

THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

BY-LAW NO. 25-1805

Being a By-Law to amend Schedule K of By-Law 24-1760 to set fees and charges for services, activities and use of municipal property.

WHEREAS

Under Section 391 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, a municipality may pass by-laws imposing fees or charges on persons:

- a) For services or activities provided or done by or on behalf of the municipality;
- b) For costs payable by the municipality for services or activities provided or done by or on behalf of any other municipality or local board; and
- c) For the use of municipal property, including property under its control.

AND WHEREAS

The Council of the Corporation of the Municipality of Temagami deems it desirable to amend Schedule "K" (Building Permit Fees) of the User Fees By-law, as amended;

NOW THEREFORE

The Council of the Corporation of the Municipality of Temagami enacts as follows:

1. Repeal and Replacement of Schedule "K"

Schedule "K" of By-law 24-1760 is hereby repealed and replaced with Schedule "K" - Building Permit Fees 2024, attached hereto and forming part of this by-law.

2. Clerical Amendments

The Clerk of the Municipality of Temagami is authorized to make minor corrections to this by-law or its schedules after its passage. Such corrections shall be limited to

grammatical or typographical errors and shall not alter the intent or substance of the by-law.

3. Effective Date

This by-law shall come into force and take effect immediately upon its final passing.
