Executive Summary

This report provides an update on two key economic and infrastructure initiatives: the Temagami Region Economic Development Corporation (TREDCO) and the Joint Councils Mine Landing Ad Hoc Committee.

- TREDCO Update: Established through By-law 24-1744, TREDCO was officially
 incorporated on August 26, 2024. The current Board of Directors has been appointed,
 and reporting requirements have been outlined. Chair Cathy Dwyer has requested to
 present the first activity report at the March 27, 2025, Working Session due to a
 scheduling conflict.
- Joint Councils Mine Landing Ad Hoc Committee: The committee, formed to address land
 use and infrastructure concerns, has held several meetings. Key discussions include legal
 counsel retention, surveyor engagement, and a review of the 2011 Parking Agreement.
 A meeting with the OMNR Land Disposition Officer was rescheduled due to the
 Provincial Election, and the next committee meeting is now set for March 18, 2025.

Council is asked to acknowledge these updates and approve the rescheduling of TREDCO's activity report presentation.

1. Temagami Region Economic Development Corporation (TREDCO)

Background

On June 27, 2024, Council passed By-law 24-1744 to authorize the incorporation of TREDCO and appoint its initial Board Members.

By-law 24-1744 Excerpt:

"NOW THEREFORE the Council of the Corporation of the Municipality of Temagami hereby enacts as follows:"

1. Incorporation Approval: Council authorized staff to register the Articles of Incorporation.

- 2. Execution of Documents: The Mayor and Acting Treasurer/Administrator were authorized to execute registration documents.
- 3. Initial Board Appointments: Allan Avard, Mike Brooker, Steve Casper, Dan Paradis, and Dave Taylor.
- 4. Clerk's Authority: Minor grammatical or typographical corrections may be made as needed.
- 5. Effective Date: The by-law came into force upon passing.

- Incorporation Date: August 26, 2024.
- First Fiscal Year: Began January 1, 2025.
