# 1. Training

- May 6<sup>th</sup> Members of the Marten River Fire Department attended the Fire Hall and received training and review on Updated Standard Operating Guidelines.
- May 20th Members of the Marten River Fire Department attended the firehall to conduct Maintenance on all Fire Vehicles, changed all snow tires over to summer tires and completed all vehicle equipment checks.
- May 26th Members of the Marten River Fire Department attended the firehall and reviewed the training of Chapter 7 and 8 of the Essentials of Firefighting

#### 2. Incidents

- May 3rd Incident #2025 12 1240 hrs
  - Medical Call
  - Handley Road
  - A 63-year-old male was in Mental Distress. En route the Fire team was advised to stage at the highway, and to not approach the home. Members stood by with Paramedics, and were cleared from the scene by OPP.
- May 6th Incident #2025 13 1231 hrs
  - Medical Call
  - ► Highway 11 North
  - A 72-year-old female was short of breath and was feeling very weak. Members tended to the patient, administered oxygen and monitored her vitals until paramedics arrived.
    Patient was transported to hospital by Ambulance
- May 12th Incident #2025 14 1327 hrs
  - Medical Call
  - Highway 11 North

- Stage 4 Cancer patient in severe pain and nausea. The team attended and assisted paramedics. The male was transported to hospital via ambulance.
- May 18th Incident #2025 15 0943 Hrs
  - MVC Motor Vehicle Struck a Moose
  - ► 3709 Highway 11 North
  - Members tended to the occupants of the vehicle and checked for any vehicle leaks. Members blocked one lane of highway to ensure scene safety for all emergency service responders and civilians. Members also assisted with traffic control as requested by the OPP, and washed down the highway prior to clearing the scene.

#### 3. Fire Prevention Initiatives

The Marten River Fire Department team members changed the sign out front of the fire hall posting a new fire safety tip. The social media page was updated with fire safety information.

#### 4. Additional Information

- In accordance with a motion passed by Council on April 24<sup>th</sup> regarding Memo 2025-M-097, the Marten River Fire Chief has put out a tender for a new pumper firetruck. This tender is active presently and is posted on the municipal website.
