#### **Activations**

There were two activations in June

- June 9<sup>th</sup> @ 10:53 PM Transport trailer tire fire Hwy 11, 4 Km south of Town, 3 trucks 9 firefighters responded, fire extinguished prior to breaching the trailer wall/floor, vehicles and equipment cleaned & back in service by 1:00 AM.
- June 22<sup>nd</sup> @ 12:15 PM hydro transformer reported on fire near 6719 Hwy 11; 3 vehicles and 4 firefighters responded, first truck on scene conducted scene analysis, fire had self-extinguished, no public safety concerns, cancelled response, location (pole #) reported to Hydro; back in service @ 12:34 PM.

# **Training**

4 practices in June, 1 equipment maintenance, 3 practices: Flammable gas under pressure, port-a-tank set-up/drafting, pump training, driver training, and Hydrant use. On schedule for completion of the in-house Firefighter Exterior with Auto-X training program for 3 firefighters for certification testing this winter.
